

## CALL FOR TENDER

### **PUBLIC PROCUREMENT FOR SELECTION OF PRIVATE PARTNER AND AWARD OF CONTRACT ON PUBLIC-PRIVATE PARTNERSHIP FOR REPLACEMENT, RATIONALIZATION AND MAINTENANCE OF THE PART OF THE PUBLIC LIGHTING SYSTEM ON THE TERRITORY OF THE CITY OF NIŠ**

Type of public procurement procedure: Open procedure

Subject of public procurement No. 404-2/15 Y-2020-28 is the award of a public contract on public-private partnership without the elements of a concession for replacement, rationalization and maintenance of the part of the public lighting system in the territory of the City of Niš.

Subject type: Services

Number of lots, if the purchase subject matter is divided into more lots: Procurement is not formed in lots.

The criterion - the elements of the award criteria:

Selection of the best tender will be made by applying the criterion “Economically most favorable tender”

The contract award criteria elements are:

1. Net current value of total contract costs ..... 90 weights and
2. Saving in annual electricity consumption ..... 10 weights.

#### Guarantee

The bank guarantee of the seriousness of tender shall amount at least RSD 15,000,000.00 - valid 30 days longer than the period of the tender validity.

#### Tender submission method and tender submission deadline:

Tenderer submits the tender directly or by mail in a sealed envelope or box, sealed in such a way that on opening the tender it can be definitely determined that it is opened for the first time, on which the Tenderer enters the following information: name, address of the headquarters, telephone number and contact person of the Tenderer, the name and address of the recipient of the tender - City of Niš - Office for Local Economic Development and Projects, 39, Generala Milojka Lešjanina str. 18105 Niš, (reception office on the second floor), number and name of the public procurement, with the indication "DO NOT OPEN".

The tender shall be considered due if received at the address above, no later than **52 (fifty-two) days from the publication date in the „Official Gazette of the Republic of Serbia“ by 12:00, on that very day.**

**Place, time and manner of opening tenders:** Public opening of tenders will take place on the same day, after the deadline for submission of tenders, **52 (fifty-two) days from the publication date in the „Official Gazette of the Republic of Serbia“ at 1:00 pm,** at the City of Niš premises, 39, Generala Milojka Lešjanina str. (first floor).

**Conditions under which Tenderer's representatives may participate in the tender opening procedure:** Tenderer`s representatives participating in the tender opening procedure are required to submit an authorization to take all actions in the public tender opening procedure and it is also advisable to submit it to the Commission immediately before opening of tenders.

**Decision deadline:** Based on the Report on the Expert Evaluation of Tenders, decision on the selection of a private partner, that is, on the suspension of the public procurement procedure, will be made by the Contracting authority within a period of 30 (thirty) days from the tender opening date.
